

CALL FOR ENTRIES

BRUSH MEMBERS' SHOW 2008: A Juried Exhibition

March 9 - April 5, 2008

An exhibition of diverse works submitted by artist members of the Brush Gallery.

ELIGIBILITY:

Membership: Artists who are members of the Brush Art Gallery. Please visit www.thebrush.org to download a membership application if necessary.

DETAILS:

Artwork: Any two dimensional or three dimensional works.

Two dimensional work must be securely wired and ready to hang. Absolutely no glass "sandwich frames" or saw tooth hangers. Size limit of approximately 6 square feet (i.e. 2 by 3 feet)

Three dimensional work may include sculpture or fine crafts. Sculpture is limited to 3 feet tall and 2 feet wide and may not exceed 30 lbs. Fine crafts must be of high quality and must be made by the artist.

Delivery: All accepted work must be hand delivered to the Brush Art Gallery. Sorry, no deliveries by postal service, UPS, FedEx, etc.

Jurors: E. Linda Poras, Executive Director/Curator The Brush Gallery, independent museum curator, fine art appraiser (Appraisers Association of America), formerly Curator of Contemporary Art, Fitchburg Art Museum; Michael Lally, Executive Director of the Whistler House Museum; James Dymont, Editor, Vyu Magazine, professional graphic designer.

Prizes: 1st, 2nd and 3rd place winners are awarded a well-publicized group show, *The Winners' Circle*, at the Brush Art Gallery

METHOD OF SELECTION: Artist's Website –or- Digital images

- **Website.** On the application form below, clearly print your website's URL in the appropriate box. We will visit your website to view your work. *Indicate on application which images you are submitting.*
- **CD.** On a CD, provide up to 3 images of your work. Each image must be titled with the name of the work. Images must be in JPEG or TIFF format, and not more than 300 DPI resolution. Clearly print your name, phone number and e-mail address **directly on the front of your CD in indelible ink.** It is suggested that you put your CD in a protective envelope. **No DVD disks, please.** After you create your CD, test it to make sure it opens and is readable on a PC.

*****Important: sorry, images cannot be accepted by e-mail.**

Notification of Jury Decision:	February 27
Delivery of work:	Delivered to Brush Gallery on March 1 (12-4) and March 2 (12-4)
Exhibition opens to public:	March 9 (Opening Reception, Sun, March 9, 2-4 PM)
Exhibition closes:	Saturday, April 5, at 4 pm
Work to be removed from the Brush Gallery	Sunday, April 6, 12-4 pm.

INSURANCE AND SALES: All artwork must be for sale. The Brush takes a 40% commission on artwork sold. The Brush insures all artwork on loan while it is at the Gallery. Artists are responsible for delivery (and insurance) of work in transit to and from the Brush Gallery

PHOTOGRAPHY: The Brush Gallery reserves the right to photograph artwork, and use photos of exhibited artwork for the purposes of documentation, education, and publicity.
